Insulation and Heat Pump News

In April, 2017, the Provincial Government announced the Home Energy Efficiency Loan Program (HEELP) to provide low-interest loans for home energy efficiency upgrades. Through HEELP, qualifying home owners whose homes are reliant on electric heat can receive financing of up to \$10,000 over five years for **heat pumps and insulation**.

About HEELP

- Eligible applicants can receive low-interest financing of Prime plus 1.5% for up to \$10,000 over five years to purchase and install heat pumps and insulation. As with any financing program, a credit check is required.
- HEELP is open to existing homes.
- We will begin accepting applications in October 2017. Stay tuned for further details!

INSULATION REBATE REMINDER

R-VALUE REQUIREMENTS

The R-Value must meet the following minimum and maximum R-Value requirements after the insulation is installed. Rebates are only available for the amount of insulation required to complete the project.



Electrical Services Financing Available Year Round!

Don't forget that financing is available for residential customers covering a wide range of energy saving products:

- · Basement and attic insulation
- Digital and programmable thermostats
- Electric water heaters
- Electric heating systems and heat pumps
- Heat Recovery Ventilators (HRV)
- · R-2000 upgrades

Once a customer is approved and the project completed, the cost of the installation is paid directly to the installer by Newfoundland Power, and the monthly finance amount is then added to the customer's electricity bill. Financing is available for residential customers with an active account. Customers must meet credit approval.



NEWFOUNDLAND POWER FINANCING

ELIGIBLE HEAT PUMP UNITS

Installed units must meet the following Heating Seasonal Performance Factor (HSPF) to ensure efficient operation in our climate:

- Mini-Split: 10 or higher
- Multi-Split: 9 or higher
- Central Heat Pump: 8.5 or higher



In order to be listed, Installers have to meet certain criteria and sign an Insulation Installer Agreement. If you would like to learn more, please email contactus@takechargenl.ca.

Installer Listing Criteria:

- Complete and submit the takeCHARGE Insulation Installer Participation Agreement.
- Be a registered business in Newfoundland & Labrador.
- Have \$1,000,000 liability insurance. Proof of insurance is to be provided.
- Follow takeCHARGE Logo Guidelines.
- Complete mandatory takeCHARGE program training.
- Join the takeCHARGE Installer Mailing List.
- Update your contact information once a year.
- Complete at least one project that leads to rebates being submitted to takeCHARGE each calendar year.
